Treasurers Report

Financial Status as of 8th June 2010:

Current Account: £581.26

High Interest Account: £17,670.49

Major item of expenditure this period has been the purchase of resin (£166.38) which will be reimbursed by BCA. I have made a payment (today) of £343.50 for concrete lintels for capping digs on Ingleborough (as previously agreed with NE) and I expect the BCA grant for 2009 (£486.21) to be in the account by early July.

Cave Rescue Manual: There are 17 remaining from the original 50 purchased.

BCA Report: The BCA bid to host the 2016 European Congress will almost certainly be accepted.

Whilst planning for the event is at a very early stage, if the bid is accepted, then the favoured location for the event would be the Dales, due to the density of excellent caves within a compact area. The date could even be linked to one of the GG winch meets, maybe extending the meet by a week to accommodate the congress. Nothing has been planned as yet, but if it is to be held in the Dales, then the co-operation of the CNCC, clubs and landowners (not to mention equipment manufacturers and suppliers) would be a key factor to the success of the Congress. The Vercors 2008 Congress was a spectacular success with cavers attending from all over Europe (and beyond) and it is hoped that the 2016 event will be as good.
