Secretaries Report to the CNCC AGM 07 March 2009

I must offer my apologies for loosing the minutes of the last AGM. This however is down to nothing more than a twist of events that wrote off my 250GB portable passport hard drive. The story, the minutes were done on a PC and saved on the portable hard drive. They were then transferred to my own PC, which when the new version of Norton was installed crashed with devastating effect and needed to be rebooted from the original disc, thus erasing all saved data. When I tried to open the portable hard drive it refused to do anything. I passed this to a government investigator to try and retrieve the information. It has now transpired that the inside has been fried. I can only conclude that I must have placed it on top of the combination microwave oven when it was in operation, which has melted the contacts and caused a short circuit.

#### Access

Leck Fell. A new entrance into Nott's Pot will be reopened during or just after the closed season. I use the term reopened because it had been open for a brief period and was then filled in by the explorers, after some concerns. I have negotiated with the diggers and agreed the following

- 1. I will negotiate with the Estate over the opening of a new entrance as an extension of the Nott's Pot system
- 2. Diggers and CNCC to reopen the entrance and under take stock proofing and other surface works as necessary within the constraints of the SSSI
- 3. A cave conservation management plan will be drafted to monitor effects of access on the formations
- 4. Conservation work to be done between the diggers and CNCC
- 5. Glenn to take a photographic record of the formations as part of the monitoring plan
- 6. General access under the Leck Fell permit system.

A meeting with the Estate managers is due to take place on 30 March 2009, where the new entrance will be discussed and a number of other issues which will include, access to Lost John's Cave during the closed season and the possibility of Lost John's Cave coming out of the permit system. And if successful to include Nott's II. Other issues include parking and Grouse shooting.

### Rigging guide volume II

I have given this a great deal of time and I am hopeful that we will have a draft ready for the summer with the possibility of a pint run late summer early Autumn.

# **CNCC Technical Group**

We have been working with the DCA representative on a revised version of the anchor installation guidelines, now called procedures. These are to be discussed and agreed at the next BCA Equipment meeting (March), I am hopeful that soon after that date I can run an anchor replacement course, although I must stress that nominations have already been completed for the first course.

#### Club accommodation and fire risk assessments

I have electronic copies of the documents for the aforementioned requirements for those who require copies. I did look at the possibility of running a course, however, the cost £310 per person for the two day course, I though would be too expensive for most clubs. However, if any club nominated safety officers want to attend a course I can book them on a course. I can give advice on undertaking a fire risk assessment, however, clubs must understand, that because of legal reasons, they will be solely responsible for following the guide and implementing amendments and alterations, both written and to the fabric of the building.

#### Training officer

It is my intention to ask the committee to accept my nomination for the post of Training Officer. I am not promising anything at this moment in time. But, I do intend to arrange for a schedule of specific training and development courses for cavers over the coming years.
