The meeting opened at 10:03am, with Matt Ewles in the chair. He explained that Andrew Hinde was unable to attend in person, and was therefore using Zoom. There were no objections to ME chairing the meeting.

1.2 VERIFICATION OF QUORUM.

With sixteen full member clubs present, including three online, the AGM was declared to be quorate. (The constitution requires a minimum of ten clubs).

2.0 DECLARATION OF CONFLICTS OF INTEREST

No conflicts of interest were declared.

3.0 APPLICATIONS FOR FULL MEMBERSHIP

3.1 Birmingham Student Caving Club

The application for Birmingham's membership was proposed at the January committee meeting by ULSA, and seconded by YCC.

JMB commented that social media confirmed the Ulster cavers were regular visitors to the Dales. RB added that they planned to attend meetings in person, as it provided a good excuse for a visit. The chair welcomed both clubs to the CNCC.

4.0 PROPOSALS FOR CONSTITUTIONAL AMENDMENTS

4.1 INDIVIDUAL CAVER REPRESENTATIVE

ME described the background to the creation of the Individual Caver Representative (IC Rep) position in 2016, and the fact no one has ever taken up the role. He further explained why the committee proposed changing the role to remove the need for the IC rep to be a BCA DIM, and allow all individuals in the room at the AGM to cast a vote for them.

This set of proposals was to remove the requirement for the IC Rep to be a BCA member, and to widen the "electorate" from BCA Direct Individual Members (DIMs) to all cavers attending the AGM.

On March 6, Craven PC emailed the Secretary with an amendment to the motions, which she circulated to all full member clubs, along with the Officer Reports.

ME explained that we are not able to accept this, as proposals for constitutional amendments must be submitted eight weeks in advance. Nevertheless, he invited Craven to explain their concerns in more detail.

RM responded on behalf of Craven, expressing concern that people may not be able to see the proposals until after the deadline for amendments. It was explained that the proposals were discussed in detail at the January committee meeting, before the deadline.

PH added that the club were also concerned that the IC Rep would have one vote as an individual, in contrast to a large club such as Craven only having one vote on behalf of over two hundred club members.

TA responded to this latter point, by describing how he encounters lots of small groups who cave independently of clubs. They currently have no representation at the CNCC. An IC Rep would be representing probably several hundred independent cavers. Having this representation would also look good when dealing with other bodies, such as the Yorkshire Dales National Park, showing that we are a truly representative body. The very fact we haven't previously had an IC Rep demonstrates that we need to remove barriers.

AS queried the situation with public liability insurance, if a non-BCA member was on the CNCC committee. This point was raised by Craven prior to the January committee meeting, and clarified by Josh White, the BCA Insurance Manager:

I've received the following wording regarding non-BCA members being able to be on CNCC committee:

In respect of who is a committee member of any body, it is a matter for the BCA as to whether they need to become a member.

They don't have to be a paid member, as their role is that of a committee member/trustee of the club.

We don't require committee members be affiliated members of the NGB, that is up to each individual NGB.

If a claim was made against a committee member in their role on the committee, this would fall under the Directors & Officers liability cover, as they are picked up under the definition of Insured Person.

In short - there is no problem from an insurance perspective with the changes Matt was proposing at the committee meeting.

Answering a question from IRW, ME confirmed that CNCC full member clubs do not need to be BCA members.

SL asked if TA would accept the role if there was no vote attached to it. TA replied that he would not, as having the vote demonstrated that they were an equal member of the committee.

RB asked how TA would reach out to these individual cavers, in order to get their voice. TA stated that he would use normal CNCC communications (email, social media, etc) to ensure they know how to get in touch. He is not coming into this role with an agenda, or particular issues he wants to propose. However he wants to see the IC role filled and is happy to stand as a representative.

Furthermore, TA explained that (as a former CNCC Access Officer) he had already worked to remove barriers. Examples include negotiating with landowners to allow permits to non-club and non-BCA cavers.

JMB explained the difference between a representative (such as the IC Rep) and a delegate. Essentially, a representative is empowered to make their own decisions, whereas a delegate is instructed to vote in a certain way.

CJB pointed out that even some BCA Council voting members don't have to be BCA members.

SC queried how individual cavers could be represented at AGMs, since only full member clubs currently have the right to vote, and suggested this might be amended in the future.

RM asked about the IC Rep's accountability, compared to the club reps being held accountable to the club's members. Also, from his perspective of BCA Chair, the CNCC and BCA are in many ways the same body, and he believes everyone should be a BCA members.

ME commented that many BCA members also cave independently of clubs. As well as DIMs, many CIMs are club members just to get insurance or for historical reasons, but they mostly cave outside their club. These cavers could be represented by the IC Representative. Hence, in addition to non-BCA cavers, the IC Representative may be providing a voice for far more BCA members than any club.

GD added that there are 1126 people on the CNCC Cave Booking System, and 230 said they are not BCA members. This is 20% of all users, a significant number.

PM said the Northern Boggarts were also initially against this proposal, but following further discussion the club is now very much in favour. We finally need to push this forward.

PROPOSAL 1

To amend point 5c of the constitution

From:

*The Committee may, only if there is an eligible applicant at the election, also include one additional member whose role it is to represent individual cavers undertaking trips outside of a club structure (known herein as the Individual Caver (IC) representative). The IC representative must be **an individual member of the BCA**, and has one vote on the Committee.*

To:

*The Committee may, only if there is an eligible applicant at the election, also include one additional member whose role it is to represent individual cavers undertaking trips outside of a club structure (known herein as the Individual Caver (IC) representative). The IC representative must be **one individual**, and has one vote on the Committee.*

Only if there are no applications received conforming to the above criteria, or if none of the applicants prove to be eligible upon voting, may applications for the vacant post of Individual Caver Representative be accepted which are made on the day from those present and eligible at the meeting..

All persons who are present at the meeting may vote for the IC representative, and should do so by each selecting one applicant.

To amend Clause 9i of the constitution as follows:

From:

Outcomes will be decided by majority vote of all voting representatives present.

To:

Outcomes will be decided by majority vote of all voting club representatives present, or, in the case of the IC representative election, of all individuals present.

and delete Clause 9j of the constitution:

The only exception is voting for the election of the IC representative, for which only attending Direct Individual Members of the British Caving Association may vote. BCA membership card to prove DIM status must be brought to the meeting to enable a vote.

4.2 CNCC NAME CHANGE

ME provided some background to the motivation behind wanting to change the name.

SL asked about the process for changing the legal name, and its effect on the bank account. PB replied that it was easy, and Barclays just required a signed letter

SL then queried the effect on access agreements. ME explained that there were very few agreements remaining, although it was something to check.

AH commented that the Fairy Holes agreement is with himself as an officer, not with the CNCC as a legal entity.

6.0 OFFICER REPORTS

6.1 Chair (AH)

Following a question from SL, AH confirmed there was no update on the High Birkwith situation.

6.2 Secretary (JMB)

JMB confirmed that the suggested date for the next AGM is 22 March 2025, and not as stated in her report.

CJB (BCA Treasurer) commented that the £1000 grant given to YUCPC was likely to be reimbursed from the BCA Y&D budget, rather than general BCA funds.

ME thanked JMB for a successful first year as secretary.

6.3 Treasurer (PB)

The Secretary apologised for including a simplified version of the accounts in the Officer Reports, rather than the original financial statements provided by the Treasurer. This was a significant error, since these documents included the signature of the independent "scrutineer" (in lieu of the usual declaration that they have scrutinised the accounts and supporting documentation).

JMB agreed to post the original documents on the CNCC website, and ME showed the signed paper copy to the meeting.

(PB announced, later in the meeting, that this will be his final year as treasurer.)

6.4 Conservation Officer (KE)

6.5 Access Officer (AW)

JMB read out a late report from AW:

My second year as access officer, I've continued to promote positive relationships with landowners when engaging with them and the wider community regarding Caving. No problems have been reported with the new arrangements with Stump Cross. We are working the Braida Garth to resolve a incident that recently took place, my thanks to John Cordingley for his support with this. I've attempted to visit several times without success. Langcliffe estate did not respond to emails, therefore recorded delivery letter will be sent.

ME gave some background to the incident at Braida Garth. A caving group had been unable to ask for permission at the farm. Their return, in the early hours, caused the dogs to start barking, so the farmer, who was worried about thieves, called the police. ME suggested that we may offer additional advice to cavers following a discussion with the farmer.

6.6 Training Officer (IP)

JMB commented that the CNCC workshops are effectively a national training programme, since people attend from all over the country. MR confirmed this, since they have now trained approximately 1000 cavers from around the UK, who say they can't get most of these courses elsewhere.

CJB said that as the BCA is currently running at a deficit, it would be helpful to reduce the amount of subsidy, perhaps by increasing the contribution from course participants. AH commented that we have great uptake, with very few empty places. We should examine the balance between attendee and CNCC contributions.

JMB highlighted ME's request for volunteers to help with PR, managing warnings, and generally keeping an eye on the CNCC website to ensure it is accurate and up-to-date

JMB thanked MR for an informative report, covering safety issues with Petzl harnesses and adjustable lanyards, plus a link to useful technical information on the BCA website.

JMB mentioned an email from Sam Allshorn, asking permission to install anchors in various places. This is not an AGM matter, so she will organise an email vote to approve these projects, rather than wait until the June committee meeting.

ME added Turbary Pot to the list (from Graham Coates) and TA requested North End Pot.

RM asked about the number of anchors available, in case other regions wished to use some. AS replied that he has over 1000 in stock.
