# **Chairman's Report**

#### **Secretary's Report**

Firstly, I would like to pay tribute to Tom Sykes, who passed away last year. Tom was the first Secretary of the CNCC (from 1963-1971) and presided not only over the setup of the Council, but over numerous access improvements during his several years in office. This was at a time when citing 'open access' was likely to see you at the wrong end of a gamekeeper's shotgun. I regret not having taken the opportunity to meet Tom in person, and that my learning of the magnitude of his pioneering efforts (from some recently discovered historical documents) came too late to have thanked him in person.

It has been another extremely eventful and productive year.

At the last AGM, attendees voted unanimously to support a suggestion by Simon Wilson to see us invest £3900 for the production of 650 IC anchors and to establish a new CNCC anchor scheme, with Simon as the Coordinator. This has progressed well, and the anchors are already being installed into caves. We have added some text to the website, as well as the recent newsletter, to provide some information for anyone interested in becoming an installer.

Due to Simon being the only trainer, resource is being prioritised to those who have a project in mind that will benefit other cavers. Approval of Damian Weare as a trainer is something I requested (as instructed) over a year ago, however, this can only be approved by the BCA E&T, who have not met for a long time. A meeting, under their new convenor, is scheduled soon.

This E&T meeting will also discuss how much the BCA will refund the CNCC for the cost of the anchors. We should get back at least ~£3.80/anchor (the cost of the BCA-preferred Bolt-Product anchors), however, we remain hopeful that the full cost will be reimbursed, given the large number of cavers from all over the UK likely to benefit from these anchors over the coming decades.

Work to establish an anchor monitoring system is still ongoing, nearly two years after this was first suggested. The first part of this is well underway; our Webmaster is working through all of our topos, numbering each anchor, to allow them to be individually referenced. Not a quick task! The next step will be to design a form that groups can use in caves to report on the condition of each anchor. I will happily take on the job of producing, distributing, and harassing cavers to participate in this, but decisions still need to be made as to what information these forms should collect.

This year has seen a discussion within the Committee about the possibility of changing the name of the CNCC; to something that perhaps indicates wider representation than just clubs; or something that sounds a little more modern. The decision was made not to change the name. A summary of discussions can be found in the July and October meeting minutes.

I am still working, albeit slowly, to put together a stall for Hidden Earth. I have always been conscious that the CNCC is the only Regional Council not to routinely do so. Since last Summer I have been starting to look at this more proactively. As part of the 'backbone' of the stall, I want to include a history/timeline of the CNCC showing all the key events, challenges and achievements since the Council was formed, as well as extensive coverage of our most recent work.

In the absence of any CNCC documents prior to 1992, I have spent many hours this year reading through past Descent magazines and other publications to try to piece this CNCC history together. However, in January, I acquired from Ric and Pat Halliwell two large boxes stuffed full of CNCC paperwork, that provided all the information I needed.

A few things struck me in this paperwork. The first folder I went through were entitled 'CNCC communications 1993'. Clearly, this was pre-internet and email. The Secretary (Les Sykes, who had recently taken over from Phil Parker) was receiving several letters each week, from people applying for membership, writing to ask what their nearest club was, asking for general information about caving, complaining about something (there was a lot of that), asking about cave access etc. Of course, this postal traffic has now been completely replaced by Google, the CNCC website, and the magic of email. Each one of these letters was replied to. As I look further back, to a time when the CNCC had over 150 member clubs, the amount of correspondence was absolutely staggering! It seems I have it quite easy by comparison!

Amongst these boxes were minutes and reports for every AGM dating back to 1964 (including the original hand-written attendance register and minutes from 1964, which presumably was the first AGM, when the Council was only one year old). I have taken advantage of the terrible weather over the past few weeks to scan all of these documents, and will upload them to the website soon. This will mean we will have a complete archive of AGM and SGM records for our entire history.

Furthermore, I also have original letters (and replies) sent by/to the first CNCC Officers in the early 1960s, trying to negotiate access to Leck, Casterton and Fountains Fells for the very first time, as well as pushing for the formation of the National Caving Association. They are fascinating reading; an insight into a pre-CRoW world where such places were seriously out of bounds. I am digitising these to ensure their preservation, as some of them are quite fragile one-off documents, and I believe they are important historical records. I will then package them up and send them to the British Caving Library. As these letters are personal correspondence I am not sure about the ethics of publishing them electronically (even 55 years on). Thoughts are welcome.

This year has seen a substantial move towards a more proactive attitude to cave access. This has been driven by Tim's excellent efforts, as you will see from his report. I agree that the course of action regarding Langcliffe Estate (Dale Head/Penyghent Pots) was the right one.

Continuing the theme, you will see in the agenda, a suggestion to extend a progressive attitude to other caves on CRoW land and adopt a 'assume no restrictions unless we know otherwise' approach. The CNCC website is full of caves on CRoW land which indicate a need to call at a house/farm (often miles away) for permission. This information is mostly extremely old, predates the CRoW act (and so represents a period where just crossing the land needed permission), and is likely to be incorrect today (due to changes to ownership details over the last two decades). I'm looking forward to discussing this at the AGM; I think it should be a very useful conversation.

The online cave booking system looks set to revolutionise managed cave access in our region, and Tim has done excellent work in demonstrating to the landowners the benefits that this offers. Gary has done an outstanding job developing the IT infrastructure for this, as will be demonstrated at the meeting. A full report is included in the recent (February) newsletter. My involvement has been

limited to putting together a 'guide document' for Ingham and Yorke (Ingleborough Estate land agents), plus a few hours testing the system here and there; it really does look excellent!

I am extremely thankful to Geoff Whittaker who has volunteered to be the system administrator for this; Geoff has become very well known to most clubs as the fastest permit-issuer in the northwest (five minutes or under sometimes)! We're delighted that Geoff is willing to help with this.

Since the last AGM I have published two more newsletters (#6, August 2017 and #7, February 2018). I have continued to use all means of communication to publicise the exciting developments this year (including the newsletter, Facebook, UKCaving and Descent).

I have continued to add, and revise/update the online cave descriptions. Since the last AGM, descriptions for Grange Rigg, Christmas Pot, Hagg Gill Pot, Hensler's Pot, Washfold Pot, FOUL Pot and some new routes in Ease Gill Caverns have been added, plus description such as Little Hull and Notts Pot have been revised for greater clarity and accuracy. Much of this is off the back of my own caving experience throughout the year, although I am pleased to say that a few other people have now started to submit descriptions, and formatting these is now on my 'to do' list. The download statistics that Gary has reported seem to suggest that it is all worthwhile. Gary has formatted and made available several new rigging topos that were provided to him by Sam Allshorn.

I'm grateful to Maz who has reinvigorated training under the CNCC name, following years of dormancy. The first aid course in January was appreciated by all attendees (see the report by Pete Monk in the February newsletter). The upcoming paperless surveying course looks like it should be popular. Maz has temporarily stepped back a bit from the role for health reasons, but I am pleased that she has stood again to enable her to continue as Training Officer as soon as she can. Thanks to John Holloway for picking up some of the work in the meantime.

Overall, it's been a great year; some of the biggest steps forward for cave access in decades (Fairy Holes, Dale Head/Penyghent, and the online booking system), and a new anchor scheme. We've seen efforts from numerous people to try to promote caving in our region. Things are changing rapidly, and for the better, thanks both to CNCC and individual efforts.

This is the first AGM in a long time where the number of clubs standing for Committee exceeds the number of vacancies. I would like to say now to whichever club does not get elected; do come along to the meetings and make your thoughts and ideas known. Like many bodies, the CNCC struggles to get participation, so your involvement, even if in a non-voting capacity is very much wanted. (The same message is true to ANYONE, club or individual, reading this wanting to get involved).

Finally, thanks to Tony Harrison for his efforts reported in the February newsletter, which has brought £2500 into CNCC funds; a very kind gesture indeed.

I am happy to continue as Secretary for a fifth year if you are not fed up of my very long reports.

#### **Conservation Officer's Report**

Teams of CNCC Volunteers have been active during the year, with support from Natural England and from the Lottery Heritage-funded Stories in Stone project.

The entrance to the Great Douk dig in the bottom of the Great Douk pothole has been reinforced by a plastic tube, a job taking two days and requiring diversion of the stream following heavy rain the night before. This dig is on the route for the many novice cavers and naturalists who visit Great Douk cave.

Volunteers from Bradford Pothole Club, with support from CNCC, assisted Natural England in tree planting near the entrance to Wilsons Cave.

It is good to see the amount of independent conservation works being carried out by cavers in the region, a notable example being the splendid work by Buttered Badgers in removing the old water tank from the bottom of Alum Pot. CNCC is always ready to try to assist cavers with conservation projects – please get in touch if you think we could be useful.

The entrance to Penyghent Pot has been stabilized, thanks to the generosity of Mike Cooper from royalties from his book *Not for the Faint Hearted*, and additional funding from the Ingleborough Dales Landscape Partnership (Stories in Stone).

The year ended on a quiet note. Natural England has revised its procedures, with more stringent risk assessments. New requirements are difficult to accommodate within or around a cave environment, and until a workable compromise is reached (which it is hoped will happen shortly), NE involvement in cave conservation work is not possible, one consequence being the temporary postponement of the Stories in Stone cave conservation strand. CNCC continues to support conservation work outside the Stories in Stone framework, and it is hoped that Stories in Stone work will recommence shortly.

New volunteers are always welcome, for weekend or weekday working parties. No specific skills are necessary, but if you have them, we will do our best to make use of them. On the job training is given as needed. Occasionally there may be the opportunity to attend a training course. Tools will be provided, but you are responsible for providing your own protective clothing - stout footwear, preferably with steel toe caps, stout gloves, weatherproof clothing, helmet. You will also need to provide your own packed lunch and hot drinks.

#### **Access Officer's Report**

Greetings to all at CNCC, northern cavers and beyond.

My sincere apologies for absence but one of the few compulsory work events I have each year decided to choose the same date as our AGM. I would have liked to be present to answer any questions particularly on taking a more progressive attitude towards access to the caves in our area which was detailed in my report to the January meeting. However, I know that both Matt and Andrew are perfectly capable of explaining any of the issues that I have been involved in.

Although a lot has happened this last year I can keep my report brief. This is mainly due to the excellent CNCC newsletter where much of my efforts have already been reported. I think it is a further sign that our region's caving is in a good place at the moment. A huge thanks to Matt for all his efforts with this and other aspects of the council.

As far as access is concerned, all seems to be moving in the right direction. This year I have concentrated mainly on the big 'caving' estates and in particular moving towards the proposed calendar based on-line cave booking system which is open to all instead of the restricted paper permit arrangement. My role has been to initiate, seek landowner support, outline the requirements of the system and progress the scheme. Huge thanks are due to Gary for the time commitment and expertise he has put into developing a professional working system. This has been crucial to our success so far. At present we are undergoing 'live' trials of the system on the Ingleborough Estate and my hopes are that by next year's AGM the system will be in common use across Leck and Casterton fells, as well as Ingleborough. When the time is right, perhaps in a few months, we are going to need the help of all clubs and northern cavers to publicise the scheme and give it our support.

On the Langcliffe Estate, we have struggled in recent years with any form of meaningful communication. The recent action regarding access, taken by the Committee, is the correct one in my opinion. I have already established a better relationship and have a meeting planned for the future. I will report on this to future Committee meetings, but I do not anticipate any further difficulties.

A number of smaller access queries have been dealt with over the year without much fuss and I am always on the lookout to improve access and promote caving more generally.

Throughout the year I have engaged with the National Park who are generally most supportive. I attended the YDNP Management Plan forum where I hope previous pestering will pay off and the new plan will see 'a raising of the profile of the underground environment and the encouragement of participation' written into it. This is likely to see a focus on better interpretation and education of the non-caving visitor but should help to improve the perception of caving in the eyes of the public in the longer term.

I was fortunate to be able to get Dales caving into a Sunday Times article and this year's edition of the Visitor. I also wrote an article for the Yorkshire Dales Review, the gist of which I used when invited to introduce the Kendal Mountain Festival's Underground Session. I was also pleased to note that the Friends of the Dales (who produce the magazine) stated that they are "very supportive of

efforts to improve access to caves and will continue to help campaign to make this happen". It is very reassuring to have such respected support for our efforts.

I am still working on getting two interpretation boards on the Three Counties System in place. The exasperating process is ongoing and is already in the second year. There is just one obstacle to overcome and I am confident we will succeed in the end.

As a BCA contact for the Sports & Recreation Alliance I recently highlighted a 'Webinar' they were running on "top tips for creating your vision and mission". Our forward-thinking Chairman was the only one to show any interest. As Access Officer, my vision is to reduce the significance of the access role within the Dales. I'd like us to spend more time promoting the cave related benefits to our area, on maintaining entrances, anchors and on conservation initiatives, in forging good relationships with all the stakeholders, keeping clubs healthy and working for the benefit of all cavers, encouraging good practice and facilitating training and more. It is a positive progressive approach which encourages participation. I am delighted to hear that we have more applicants for the Committee than we have places. It is a good sign — who wouldn't want to be part of it?

I'm happy to stand for another year if you'll have me.

# **Training Officer's Report**

# **Anchor Coordinator's Report**

There was a drop-off in the rate of installations around the middle of 2017 but now things are progressing quite satisfactorily. Mark Sims and Gary Douthwaite have become installers. 10 anchors have been installed in Pippikin Pot and that project is now completed. 7 have been installed in Quaking Pot and 8 in Pasture Gill Pot and those two projects are in progress. The total number of IC anchors installed is now 355.

Since I reported replacing loose anchors in Sell Gill in October 2017 no loose anchors have been replaced. This is because there is doubt about placing anchors in oversized holes. I intend to investigate using a different type of resin when placing anchors in oversized holes.

A date has not yet been set for the next E&T committee meeting.

#### Webmaster's Report

Aside from general maintenance there have been no significant changes to the CNCC public website however lots of work has been going on behind the scenes in the preparation and testing of the online booking system.

Work on the booking system has been on-going for several months with consultation from Tim Allen and Geoff Whitaker. The service has not gone into phase one testing with a handful of volunteers who will be using it to make bookings from now on instead of the usual permit system. Geoff is managing this alongside the usual system which is continuing as normal. Once I have feedback from the testers and any issues sorted out it will be opened up to all cavers subject to the land agent being happy.

# **Site Security**

As part of the booking system the website is now secured with an SSL certificate to help protect user data. Several web browsers now give a warning on any login pages if the site is not secure, so this measure is quite important. The certificate is provided by GeoTrust at a cost of around £30 per year, however this will no longer be payable as the site will move to Let's Encrypt from next year which is free.

# **Email Upgrades**

In order to help ensure that emails are delivered to members, one of the email accounts has been upgraded to the Office 365 infrastructure on Microsoft Exchange which is significantly more reliable. All outgoing emails from the mailing list will be routed through this address (appearing as info@cncc.org.uk to recipients) as well as delivery from online forms such as the 'report defective anchor' form. To maximise value, this email mailbox is also used for secretary@cncc.org.uk. There is an annual cost to this of around £50.



# **Meets Secretary's Reports**

#### <u>Casterton Fell – Hannah Walker</u>

#### Changes to permit applications

In order to ensure that the CNCC is not restricting access beyond what is agreed in the access agreement, some changes have been made to how Casterton Fell permits are issued. It is no longer a requirement to send letter-headed requests for Casterton Fell permits, as there is no mention of this in the access agreement. An email or a letter is sufficient.

In addition, Casterton Fell permits do not have to be for a specified entrance, but rather apply to any entrance on Casterton Fell. To reflect that, permits are now sent with the following information:

"Please note: Although this permit shows a named cave entrance/entrances, this is actually a permit for caving on the fell. Therefore it is considered acceptable to use this permit to visit any of the entrances on Casterton Fell providing all other conditions are followed. If considering using this permit to visit a different entrance to that specified you are recommended to view the Google calendar (https://goo.gl/inFBIQ) and to be courteous to any groups already booked in for that cave entrance."

#### Note about Lancaster Hole

Although the 2013 access agreement restricts the total number of permits to 5 on weekend days, 3 on bank holidays, and 2 on all other days, there is no restriction on the number of permits for a specific entrance (i.e. all five permits could be for the same entrance), and no restriction on the number of entrances that can be listed on a permit.

On the advice of the previous Casterton Fell Meets Secretary (Alan Speight), and based on my own experience, I have in the past limited the number of permits for Lancaster Hole to 2 per day, or 3 in circumstances where the clubs concerned were in communication with each other so that they could coordinate their trips (e.g. share ropes). Even with the restriction of 2 or 3 permits per day I have heard cavers complain when they had a permit for Lancaster Hole and found another team there with a permit. The majority of applicants have been happy to choose an alternative entrance or Dales caving area for their trip. These restrictions were designed for the benefit of cavers and not for the benefit of the Landowner or for cave conservation reasons.

Clubs continue to apply for permits to specific caves, and I enter these details in the Google calendar, so ideally cavers who decide to descend a different entrance will avoid Lancaster Hole if it is apparent by looking at the calendar that other groups are intending to go there. However it is likely that making each permit applicable to the whole fell means that there will be more visits to Lancaster Hole on wet days, and more than 2 or 3 teams choosing to descend on some days.

Unless the committee advises me otherwise I will not "officially" restrict permit for Lancaster Hole but I will suggest to applicants that they choose a different entrance if 2 or 3 permits have already been issued for that day, with the caveat that clubs who have not requested a Lancaster Hole permit may visit there anyway.

# Permits this year

Between March 2017 and February 2018 (inclusive), 255 permits were issued to 53 clubs. One application was received in the post. A small number of requests came from non-BCA clubs or groups, BCA individual members (one of whom was a CIC trainee), and a group of Duke of Edinburgh students based at an outdoor centre. I did not send these permits since the access agreement states that they can only be sent to CNCC member clubs (which includes all BCA member clubs).

# **Aygill and Ingleborough - Geoff Whittaker**

# **Aygill Caverns:**

During the last 12 months, 17 BCA member clubs have requested a total of 26 permits for Aygill Caverns. This has been a slight increase on the previous 12 months.

Ingham and Yorke have had monthly reports for Aygill Caverns and no issues have been reported.

## **Ingleborough Estate/Allotment and Newby Moss:**

Since March 2017 to date, 42 BCA member clubs have requested a total of 200 permits with a further 26 permits issued for 7 DIM's/CIM's, making a total of 226 permits issued during the last 12 months. On balance, permits issued to BCA member clubs are similar to the previous 12 months, however, permit requests from individual CIM'/DIM's were down 45%.

Looking forward from this month, 52 permits have already been issued and are now entered on the online system.

Ingham and Yorke have had monthly reports as usual and no issues have been reported.

## Whitewell Pot area – Tony Brown

## **Excalibur Pot – Matt Ewles**

I issued three permits for Excalibur Pot from March 2017-February 2018 and have so far issued one for the rest of 2018. A small but steady trickle of interest. No issues to report.

#### Birks Fell, Robinsons Pot, Ludwell Fairy Holes and Mongo Gill - Ric Halliwell

I have issued all the Robinson's Pot permits for this year.

There are 4 permits remaining for Fairy Holes this year (June, October, November, December).

I have issued 10 permits for Birks Fell and 2 for Mongo Gill so maybe the number of cavers visiting these sites is finally on the increase. The Mongo Gill access agreement needs renewing this year and I have had my first discussions with the owners of Stump Cross to see whether they are willing to change from Clubs only to individuals too. I won't be seeing the owners again until April but there is no question that the agreement will be renewed.
